The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

DISCLOSURE: Certain funeral services may be provided off-premises by other funeral service providers.

This price list is offered to comply with the Federal Trade Commission's Trade Regulation Rule, Funeral Industry Practices 16 CFR Part 453. Our fees, based on our expenses, are established in consultation with a professional advisory firm, exclusively serving funeral homes.

Professional Services

1 Basic Services of Funeral Director and Staff

\$ 2,150

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial requests for service 24 hours every day; arrangement conference with family or responsible party to discuss desired funeral or cremation plans; preparation and filing of required authorizations and permits for disposition (does not include international shipment paperwork processing); recording vital statistics and filing of the death certificate; if desired, preparation and placement of obituary notices; sheltering of the deceased; coordination of all details with the family, clergy, fraternal organizations, cemetery and/or crematory and all parties involved in ceremonies and final disposition; administrative after care services following the funeral; grief resources. Also included in this charge are overhead expenses relative to the use of basic facilities, including preparation room, arrangement offices, lobbies and restroom facilities, administrative offices and parking lots.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. [This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.]

2 Embalming

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

3 Other Preparation of the Body

- A. *Cosmetology, Restorative Art, Dressing and Placement of the Deceased in a Casket or Alternative Container* Our charge for hairdresser is not included in this fee. \$ 200
- B. *Basic Preparation and Care of Deceased for Identification Viewing* \$ 95
- C. *Special Treatment and Care Following Organ, Bone and/or Tissue Donation* \$ 125
- D. *Refrigeration of Deceased (up to 4 days)* \$ 125
- E. *Refrigeration of Deceased (after 4 days) Per Day* \$ 100

Virginia law requires a funeral home to refrigerate an unembalmed body if the body is to be stored for more than 48 hours prior to burial or cremation [See Code of Virginia § 54.1-2811.1. Handling and storage of human remains.]

Automotive Equipment

Additional fees may apply when transportation to or from another location requires overnight stay due to distance.

- 4 **Transfer of Remains to Funeral Home** (*within 50 mile radius*) \$ 395

The charge for additional mileage is \$2.50 per mile, one way.

5 **Automotive Equipment for the Funeral and Additional Transportation**

- A. *Hearse and Driver (within 50 mile radius)* \$ 275
The charge for additional mileage is \$2.50 per mile, one way.
- B. *Utility Van and Driver for Equipment and Flower Delivery (within 50 mile radius)* \$ 135

Special Services

7 Forwarding of Remains to Another Funeral Home **\$ 2,150**

Our charge includes basic services of funeral director and staff, embalming, transfer of remains to funeral home within 50 miles (\$2.50 per mile beyond 50 mile radius). Transportation to airport is additional. This charge does not include required minimum shipping container, visitation or ceremonies prior to forwarding of the body.

8 International Forwarding of Remains to Another Funeral Home **\$ 2,800**

Our charge includes basic services of funeral director and staff, embalming and transfer of remains to funeral home within 50 miles (\$2.50 per mile beyond 50 mile radius). Transportation to airport is additional. Also, when the remains will be forwarded outside the United States, there will be a charge of \$650 for International Forwarding of Remains which includes travel to Richmond, Va., to obtain necessary documents from the Secretary of the Commonwealth and translation of documents. This charge does not include required minimum shipping container, visitation or ceremonies prior to forwarding of the body.

9 Receiving Remains from Another Funeral Home **\$ 1,825**

Our charge includes basic service of funeral director and staff, temporary shelter of remains and transportation of remains to cemetery or crematory. Add to the fee of \$1,825 any additional services such as visitation, graveside service, service at our chapel or another facility, and flower delivery.

10 Immediate Burial

\$ 2,820 - \$ 9,320

Our charge for an immediate burial includes basic services of funeral director and staff; transfer of remains to funeral home (within 50 mile radius; \$2.50 per mile beyond 50 miles); hearse and driver to cemetery (within 50 mile radius; \$2.50 per mile beyond 50 miles). *Add \$125 for Refrigeration of the Deceased if body is to be stored for more than 48 hours prior to burial.*

11 Direct Cremation

\$ 3,000 - \$ 9,500

(Medical Examiner fee is an extra charge and varies by state)

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of cardboard with a painted finish or of wood composite, and both include small pillow. These containers are leak resistant as required by the Rules and Regulations of the Virginia Board of Funeral Directors and Embalmers. Our direct cremation charge includes transfer of remains to funeral home, basic services of funeral director and staff, and use of crematory. Public viewing and/or funeral ceremony is NOT included. *Add \$100 for Refrigeration of the Deceased if body is to be stored for more than 48 hours prior to burial.*

12 Natural Burial Package with Visitation and Funeral Service

\$ 3,945

Our charge for a Natural Burial service includes basic services of funeral director and staff; other preparation of the body (without embalming); transfer of remains to funeral home (within 50 mile radius); hearse and driver (within 50 mile radius); use of utility van for equipment and flower delivery; use of facilities, equipment and staff for visitation on- or off-premise; use of facilities, equipment and staff for funeral service on- or off-premise. Families may choose additional services such as refrigeration of the deceased (up to four days) for an additional cost of \$125, or embalming of the deceased using Green Burial Council-approved solutions for an additional cost of \$650.

13 Receiving of Cremated Remains for Services

Our charge includes administrative support, use of facilities, equipment and staff.
